Why our Legal Assist Product?

Why subscribe to our Legal Assist product?

Who can Subscribe?

Any South African citizen over the age of 18 years or foreigner who has legal standing in South Africa. The service is only provided in South Africa and only regarding matters which occur in South Africa. The membership covers the main member, spouse/partner and all children under 21.

What are the Costs?

The Legal Assist subscription is R68 per month. There is a once-off administration fee of R150 which must be paid with the first premium. (A 10% annual increase applies.)

When do the Benefits start?

The benefits start after 3 months of the first premium being paid and applies to incidents which happen or originate after the waiting period has expired. At our discretion we may provide you with advice in respect of matters which arose prior to the waiting period expiring.

The Funeral Cover benefit provides cover to the main member as follows:
25% cover after 6 months, 50% cover after 12 months, 75% cover after 18 months and 100% cover after 24 months. In order to benefit from the funeral cover, the subscription to the Legal Assist product must remain paid up at all times. All other rules which apply to the funeral cover is set out on our website and will be provided in the Legal Assist participation certificate.

How do I make use of the Service?
